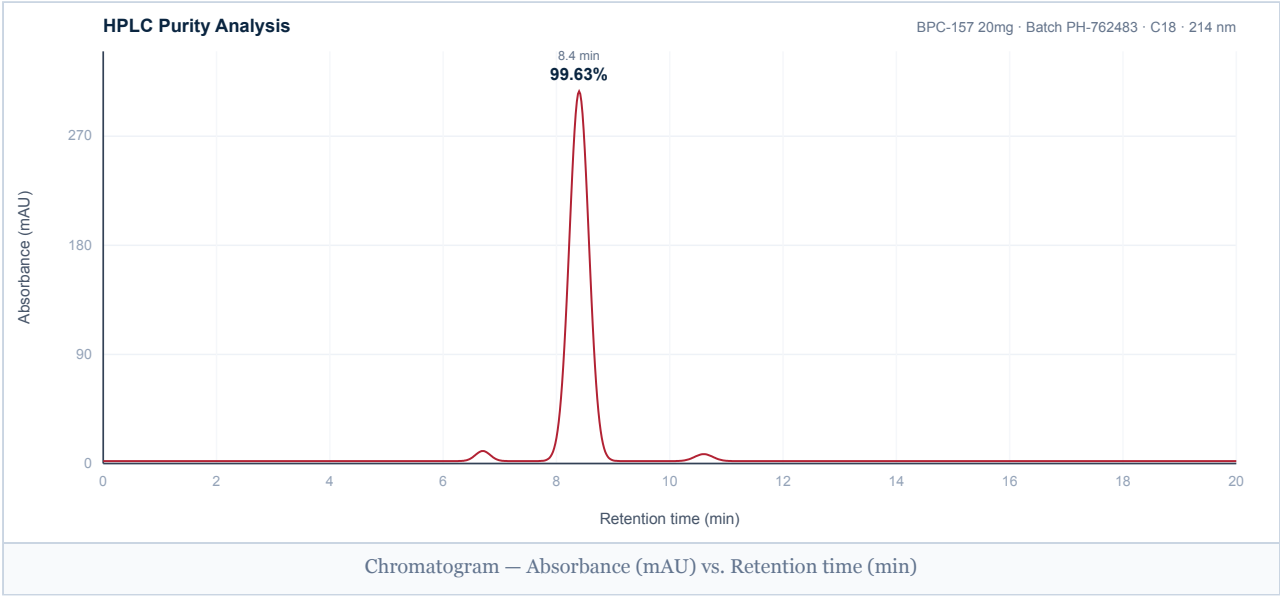

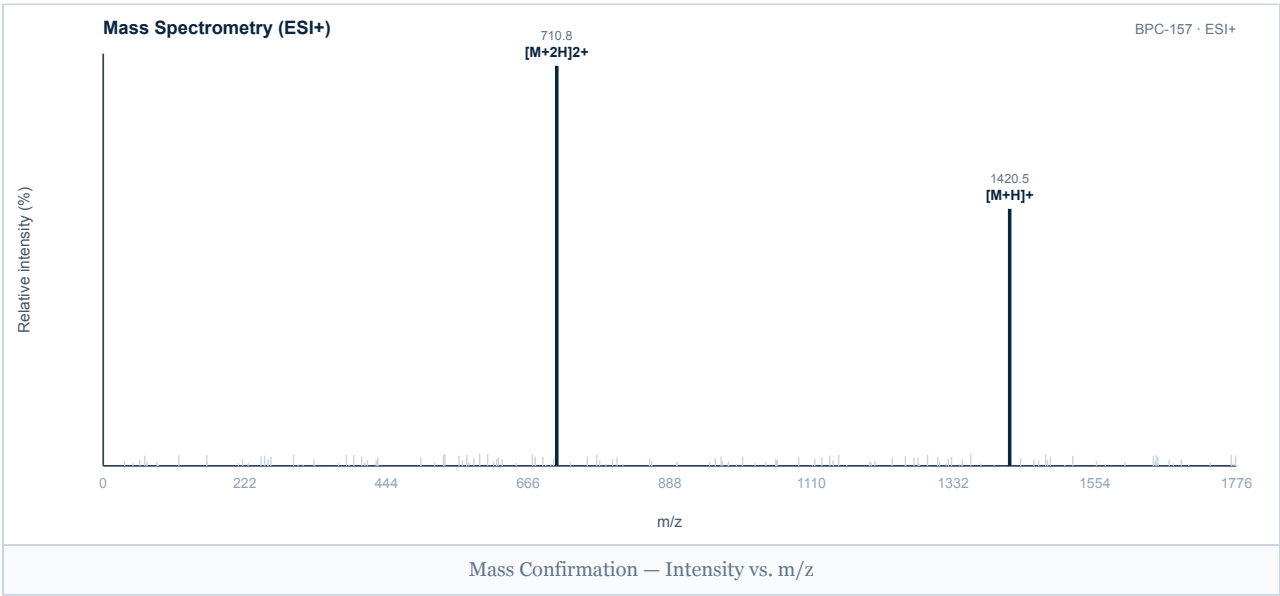

CONCLUSION

Identity of BPC-157 confirmed by LC-MS (deconvoluted mass 1419.53 Da matches the theoretical 1419.53 Da within tolerance). HPLC purity 99.63%. Measured content 20.16 mg is within ±10% of the 20 mg label claim. Endotoxin,

heavy metals and sterility screening within acceptance limits. Sample passes.

Body Protection Compound-157 (pentadecapeptide). Minor peptide-related impurities (deletion/truncated sequences) detected at trace levels; each individual impurity below the 0.5% identification threshold (Ph. Eur. Substances for Pharmaceutical Use).
