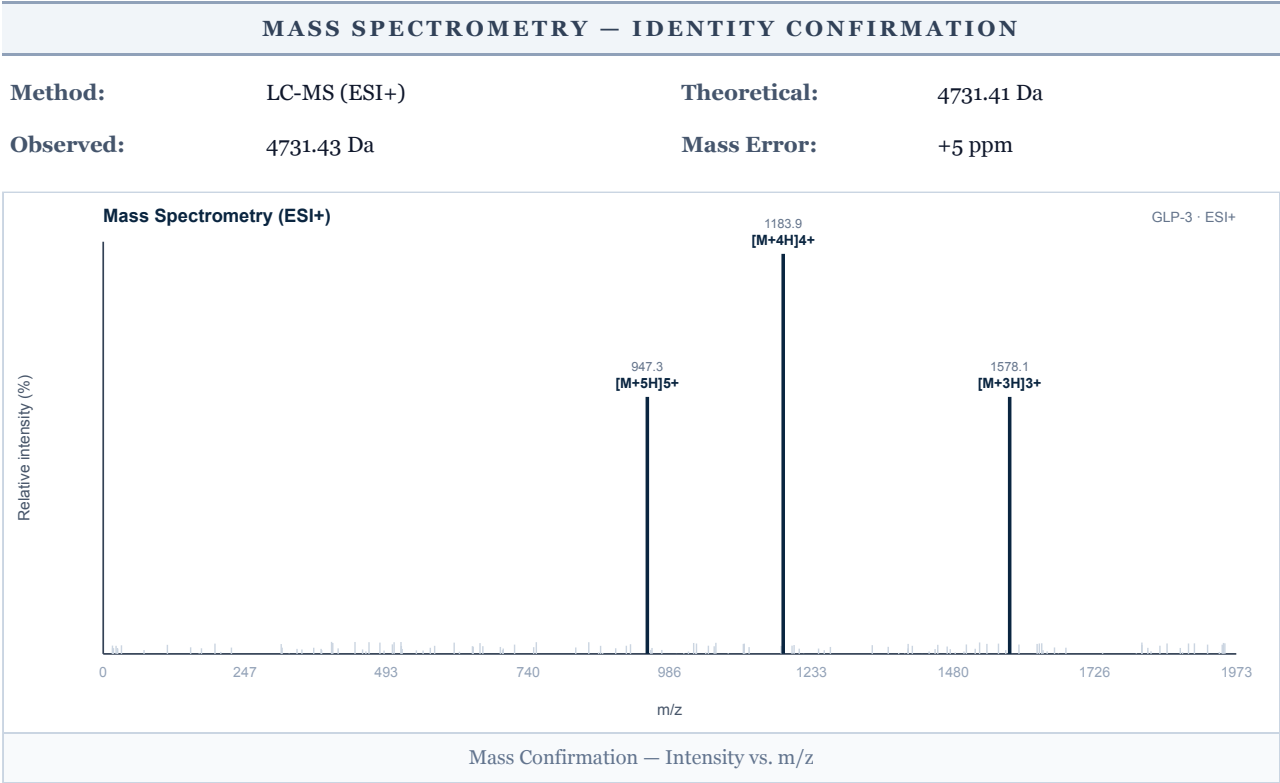
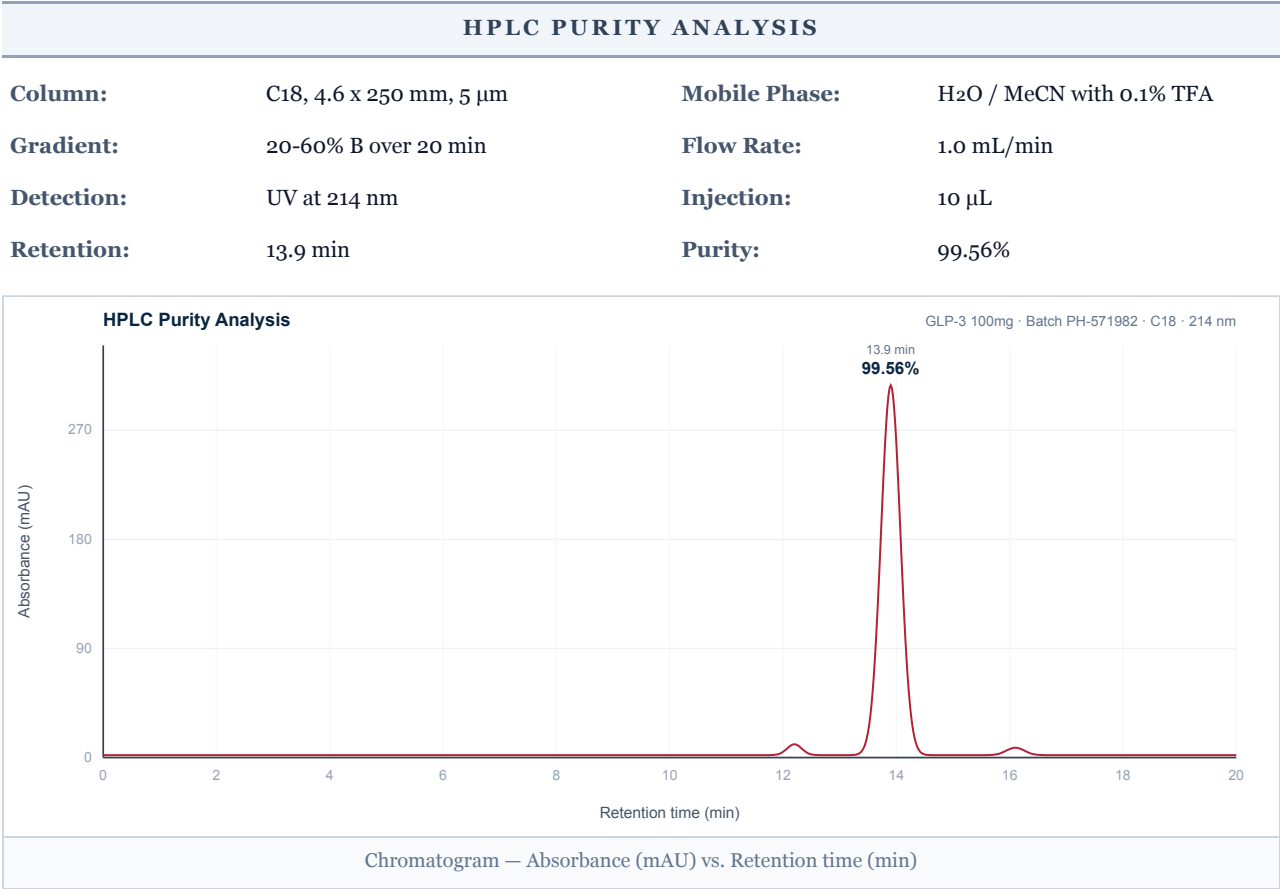

CONCLUSION

Identity of GLP-3 confirmed by LC-MS (deconvoluted mass 4731.43 Da matches the theoretical 4731.41 Da within tolerance). HPLC purity 99.56%. Measured content 99.40 mg is within $\pm 10\%$ of the 100 mg label claim. Endotoxin, heavy metals and sterility screening within acceptance limits. Sample passes.

Triple GIP / GLP-1 / glucagon receptor agonist (retatrutide analog). Minor peptide-related impurities (deletion/truncated sequences) detected at trace levels; each individual impurity below the 0.5% identification threshold (Ph. Eur. Substances for Pharmaceutical Use).
